- Bidder may offer capacity lower than 5 MWh/h, but not lower than 1 MWh/h
- Offered capacity shall be rounded to the first whole number (1 MWh/h) and shall refer to the entire period of delivery
- All time specifications refer to CET.

#### **ECONOMIC SPECIFICATIONS:**

- The amount of the guarantee for the seriousness of the offer for each MWh/h is: 7.500,00 EUR
- Terms of payment: 15 days following the reception of the original invoice
- Amount of guarantee for the proper performance: 10% of the value of the Contract for the requested delivery period

Bidders in their bids for an individual Group may also offer less power than the total requested, but not less than 1 MWh/h.
